## INDEMNIFICATION, HOLD HARMLESS AND RELEASE OF LIABILITY AGREEMENT

In consideration for the privilege of engaging in the recreational activities of skeet shooting, target shooting or hunting at the Stafford Fish and Game Club (hereinafter referred to as the "Club"), I \_\_\_\_\_ hereby agree that:

1. I understand that there are inherent risks involved, including the risk of serious physical injury or death, in participating in the types of sporting activities offered at the Club, and I further understand that these activities may take place anywhere on the Club property at any time of any day, and I further understand that any use of the Club property exposes me to these inherent risks, whether or not I am participating in any activities, and with the understanding of the risks involved I fully assume all risks associated with engaging in recreational activities at the Club, even if due to the NEGLIGENCE of the Club and its Affiliates, Officers, Directors, Agents, Servants and/or Employees, including but not limited to, handling and transporting firearms and ammunition, skeet shooting, rifle and pistol shooting, organized shooting events, hunting, lack of warnings or inadequate warnings, lack of safety devices or inadequate safety devices, lack of instructions or inadequate instructions, and the use of any Club equipment.
2. I, for myself and for my heirs, assigns, successors, executors, administrators, and legal representatives, agree I will defend, indemnify and hold harmless the Club, its Affiliates, officers, Directors, Agents, Servants and/or Employees from any and all claims, suits or demands by anyone arising from my recreational use of the Club property including claims of NEGLIGENCE of the Club, its Affiliates, Officers, Directors, Agents, Servants and/or Employees.
3. I, for myself and for my heirs, assigns, successors, executors, administrators, and legal representatives, hereby release, and agree that I will not sue the Club, its affiliates, Officers, Directors, Agents, Servants and/or Employees for money damages for personal injury or property damage sustained by me while engaging in recreational activities at the Club even due to the NEGLIGENCE of the Club, its Affiliates, Officers, Directors, Agents, Servants and/or Employees.
4. I understand that this release applies to the recreational activities of skeet shooting, firearms hunting and any other firearms shooting on the Club property.

I have read this Indemnification, Hold Harmless and Release of Liability Agreement and fully understand its terms. I further understand that by signing this agreement that I am giving up substantial legal rights. I have not been induced to sign this agreement by any promise or representation and I sign it voluntarily and of my own free will.

If I am less than eighteen (18) years of age, the person signing on my behalf is my legal guardian, has read this Indemnification, Hold Harmless and Release of Liability Agreement, and fully understands its terms, and by signing this agreement, has given up substantial legal rights of mine.
